MANAGERS' COMMENTARY

In June, ResMed was among the top performers. The medical equipment company reported third-quarter 20/21 results that were ahead of expectations and announced the launch of its latest sleep apnea device, 'Air Sense 11'. Also beneficial for the company's share price was news of a substantial recall and replacement exercise from competitor Philips for its own sleep product. Wuxi Biologic also fared well. The Chinese pharmaceutical company's investor day in June provided a granular run-through of the business, which demonstrated an increasing win rate in new business and continued high share of new industry projects. Nvidia, which designs graphics processing units for gaming and professional markets was also strong during the period, after positive earnings results which were well ahead of expectations.

On the other side, Tencent was a notable underperformer. The internet giant struggled in the period with the market still getting to grips with anti-monopoly regulations but also reacting to planned new investments by the company which will slow profit growth in the short term. Luxury jacket manufacturer Moncler was also among the weaker performers as a result of profit taking by investors. Medical precision instruments and services company Mettler-Toledo was another notable detractor during the month.

Over the month, we sold the position in Mettler-Toledo. The stock has performed strongly with limited upside to our price target. We have

reinvested the sales proceeds to increase holdings in Nvidia and Veeva.

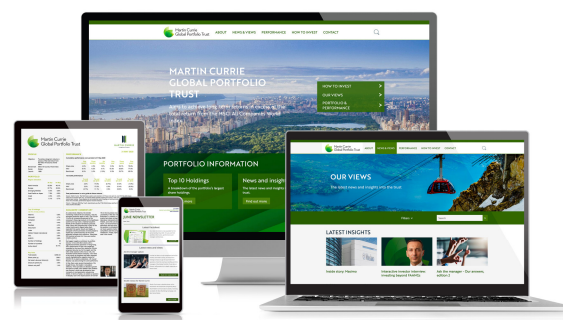
Zehrid Osmani
