## MANAGERS' COMMENTARY

At the stock level, ResMed – the global leader in medical devices treating sleep apnea – was the strongest performer in the portfolio with the share price remaining strong after the company reported solid fourth-quarter numbers at the end of July. ResMed beat growth estimates, and guidance for next year was better than expected at the margin level. Consumer goods giant Unilever was another notable positive for the portfolio as was Automatic Data Processing, a US provider of human resources management software and services.

On the other side, the biggest drag on performance in August was UK financial services company Prudential. Despite a solid operating performance, the stock has struggled against the backdrop of some unfavourable macro developments including Brexit and US regulatory reform. Chinese internet platform Tencent also suffered following second-quarter results which were in line with expectations in terms of profits, but a little weak on revenue. Against a less-favourable Chinese macro environment, the results indicated a clear weakness in advertising. However, management commentary on its games segment was positive, especially as the second half of the year is expected to include some important new launches. Swedish lock manufacturer Assa Abloy was another notable negative.

In terms of portfolio activity, we sold Prudential. As well as the issues noted above, the conglomerate nature of the business – which groups together three fairly independent units (UK, US and Asia) – has proved to be a drag

rather than a benefit, as ongoing scepticism on the quality and the prospects of the US business has weighed on the group's overall valuation. Given our lower conviction against other held names, we decided to exit the position.

## MANAGER'S BIOGRAPHY

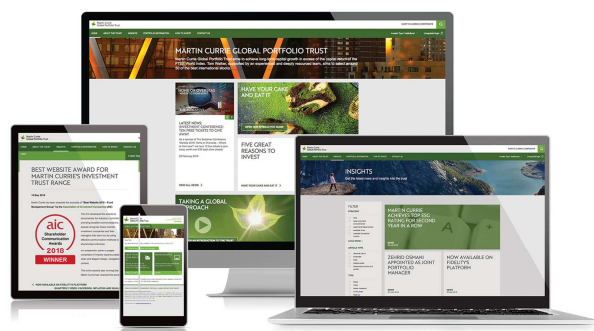
Zehrid Osmani
