MANAGER COMMENTARY

February saw falling markets and increased volatility across the globe with the Russian invasion of the Ukraine. Against this backdrop, Coloplast and ResMed, two medical devices companies did perform positively. Healthcare firms can be seen by the market as safe havens during periods of geopolitical and macroeconomic disruption. Coloplast is a Danish medical devices firm that specialises in urology and ostomy that produces products with low average selling price and ResMed is a US-listed company that focuses on sleeping and respiratory disorders. Also positive during the month, was Swedish sensor, software and automation specialist Hexagon. The firm announced positive results from the fourth quarter in 2021 and an upbeat outlook for 2022.

Masimo, the US-listed global medical technology company was the largest detractor over the month. After releasing its financial results for 2021 which were in line with market expectations, the company announced the acquisition of Sound United. This is a consumer audio brand company and the share price reacted negatively to the news as this was seen as a departure from Masimo's core healthcare business. Management has since confirmed rather than diversifying from healthcare, the acquisition was to drive product penetration in the consumer health segment rather than develop the capability in-house. Taiwan Semiconductor detracted due to negative market sentiment on cyclical sectors such as semiconductors, and from the perceived risk of increased Taiwan/China tensions in the wake of

the Ukraine crisis. Adobe, the US software company was also negative due to concerns about a deceleration in the firm's product revenue growth post pandemic.

During the month there were no outright buys or sells.

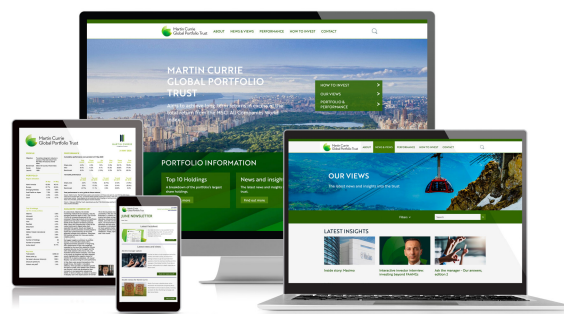
Zehrid Osmani

Funds are rated for up to three time periods—three-, five-, and 10 years—and these ratings are combined to produce an overall rating. Funds with less than three years of history are not rated. Ratings are objective, based entirely on a mathematical evaluation of past performance.
