## MANAGERS' COMMENTARY

At a stock level, Taiwan Semiconductor Manufacturing Company provided the best returns during the month, buoyed by decent quarterly results and a positive statement from the firm on its business cycle. The electronics multinational Philips also fared well on the back of good results with revenue and cash generation ahead of expectations. Elsewhere, software giant Microsoft was another notable positive for the portfolio.

On the other side, security services provider Securitas was the biggest drag on performance after quarterly results highlighted some weakness in its European operations which the company is trying to address. UK brickmaker Ibstock struggled as well during the month. The firm was able to post decent results, although margins in concrete disappointed due to scheduled maintenance and there some weakness in its Southeast market which also weighed on sentiment. Samsung Electronics was another notable underperformer after it delayed an anticipated update on its shareholder return intentions. It did, however, comment on expectations for a better second half of the year in semiconductors.

In terms of portfolio activity, we added international distribution and services group Bunzl. The firm provides customised solutions to business-to-business customers in 31 countries and across six market sectors. Its value proposition is that outsourcing to Bunzl adds value for customers by reducing the cost

to process in-house procurement and self-distribution. During the month, we exited positions in insurance group AIA and financial giant HSBC.
